Class Environmental Assessments for Minor Transmission Facilities Skyview 1 & Skyview 2 Battery Energy Storage Projects

PR Development LP (the "Qualified Applicant"), and affiliate of Potentia Renewables Inc., through its subsidiary Skyview BESS Limited Partnership ("Proponent") is initiating Class Environmental Assessments for Minor Transmission Facilities ("Class EA") (Hydro One, 2022) to construct the Skyview 1 Battery Energy Storage Project ("Skyview 1 BESS") and the Skyview 2 Battery Energy Storage Project ("Skyview 2 BESS") in the Township of Edwardsburgh Cardinal. The projects are lithium-ion battery storage projects designed with the intention of addressing the growing electricity needs of eastern Ontario. The Independent Electricity System Operator (IESO) is forecasting a need for 4,000 Megawatt ("MW") by 2030 and is in the process of administering various procurement programs to address this need.

Skyview 1 BESS is sized to provide up to 340 MW over four hours, (1,360 MWh) and Skyview 2 BESS is sized to provide up to 450MW (1,800 MWh). Both projects are proposed on approximately 30 acres of rural land north of Dobbie Road. A map of the Project area is provided at the end of this Notice. The Projects are subject to the Class EA in accordance with the Ontario Environmental Assessment Act. We invite you to join our upcoming community meeting to learn more about the proposed Projects and to speak directly with members of our Project team.


